

Parental Consent for Participation in Training Projects of Fröbel Akademie gGmbH

Fröbel, as a nationwide provider of numerous educational institutions for training educators, feels particularly committed to this responsibility and, therefore, offers the vocational school program in social pedagogy through Fröbel Akademie gGmbH in a three-year, part-time format alongside employment. To closely integrate the two learning environments of practice and school and to establish a continuous theory-practice transfer, students at Fröbel Akademie regularly receive assignments for practical application. These tasks include aspects of child development as well as educational and interaction processes of the child, such as behavior during play with other children or adults. In some cases, these projects may be accompanied by photographs, audio, or video recordings. The results of these observations are presented and discussed exclusively within the semester group. The use and sharing of personal data with third parties (e.g., videos where faces are recognizable) are strictly prohibited. The publication of personal data, such as the use of photos or videos in presentations or publications, is only possible with explicit additional consent in a separate declaration of consent. Photo or video recordings are stored and processed on iPads owned by Fröbel Akademie and on the company-owned server of the Fröbel Group (Fröbel Akademie gGmbH, Fröbel Bildung und Erziehung gGmbH, and Fröbel e.V.). The data is not stored in a cloud. Other personal data (date of birth or age, gender, or other relevant characteristics) of your child will be collected by students only in an anonymized form.

Participation in the respective training project is voluntary, and your child has the option to withdraw from participation at any time without giving reasons and without any negative consequences. Any contrary wish expressed by your child, either to not participate from the outset or to withdraw from an ongoing project, will be fully respected.

Task in Learning Situation 2 – **Understanding Play as a Fundamental Form of a Child's World Discovery:** Creation of an explanatory film that illustrates the educational significance and development of children's play (observation and documentation of children's play)

Task in Learning Situation 3 – **Recognizing Magical Educational Moments in Everyday Life:** Documentation of a moment in which a child explores and discovers a realization or skill (conducting unstructured observations and analysis based on learning theories).

Task in Learning Situation 5 – **Promoting Language Acquisition and Development Through Interaction:** Students record their interactions with children on video and reflect on them collegially.

Task in Learning Situation 6 – **Engaging in Dialogue with Children and Families About Educational Moments:** Students write an educational and learning story based on unstructured observations.

Task in Learning Situation 7 – **Successfully Managing the Transition Period:** Students document the core phase of an adaptation period in the form of an adaptation protocol or the transition from nursery to elementary care.

Task in Learning Situation 8 – **Addressing Children's Educational Topics and Professionally Structuring Educational Work in Various Educational Areas:** Planning, execution, evaluation, and documentation of three structured educational activities.

Task in Learning Situation 9 – **Organizing a Parent Evening Event.**

Task in Learning Situation 11 – **Writing a Development Report:** Observation and documentation of development using the Kuno Beller table as well as a resource-oriented analysis and description.
